



- Links to FAQs, Change log & Toolbox
- Information about the Working Group



#### **Selection of Working Group**

- The Company Member is informed about the Working Group workflow and the APQP4Wind organization.
- The information includes:
- Projects within the Working Group
- Frequency of meetings (how, when and where)
- Names of Working Group Members
- Location of shared files
- How to join the Working Group

### Approval and setup of new Working Group team member

- The new team member will be introduced into the Working Group when:
- Approval by Group Leader and Board of Directors is completed.
- The new team member' skills and ability to work actively with the group are sufficient (clarification of background).
- The number of necessary people has not reached the limit (7-9 people is preferred). Each Working Group consists of a small 'Core Team' (2-3 people) plus collaborators (4-6 additional people in the group).
- An invitation will then be sent out by the Working Group Leader, who will also organize an introduction to all Working Group Members at the next meeting.



#### Non-successful and successful Working Group applications

- In case an application for becoming a member of a Working Group is denied by the Group Leader, the APQP4Wind Secretariat will send a standard email with the information to the applicant.
- If the Group Leader approves the application, a member of the Board of Directors will sign it off and inform the APQP4Wind Secretariat to welcome the new member. The APQP4Wind Secretariat will then send the information along with a Welcome Letter to the applicant (CC: Group Leader).

 After the Working Group selection and approval, the new team member will be able to participate in the scheduled meetings organized in MS Teams and have access to the shared documents and contact information of the other team members.
